Cookies a small text file placed on your computer by this Website when you visit certain parts of the Website and/or when you use certain features of the Website. Details of the cookies used by this Website are set out in the clause below (Cookies).

 - b. references to sub-clauses, clauses, schedules, or appendices are to sub-clauses, clauses, schedules, or appendices of this privacy policy.

- c. a reference to a person includes firms, companies, government entities, trusts and partnerships.
- d. "including" is understood to mean "including without limitation".
- e. reference to any statutory provision includes any modification or amendment of it.
- f. the headings and sub-headings do not form part of this privacy policy.

Scope of this privacy policy

- 4. This privacy policy applies only to the actions of Nikki French Counselling and Users with respect to this Service/Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links it may provide to social media websites.

Data collected

Data that is given to me by you

- 9. Nikki French Counselling will collect your Data in several ways, for example:

- b. When you contact me by telephone or email
- c. When you use the Website
- 10. in each case, in accordance with this privacy policy.

Data that is collected automatically

- 11. To the extent that you access the Website, I will collect your Data automatically, for example:
 - a. I automatically collect some information about your visit to the Website. This information helps me to make improvements to Website content and navigation and includes your IP address, the date, times and frequency with which you access the Website and the way you use and interact with its content.

Data retention

Your rights

- 20. You have the following rights in relation to your Data:

If I provide you with access to the information I hold about you, I will not charge you for this, unless your request is "manifestly unfounded or excessive."  - b. Right to correct- the right to have your Data rectified if it is inaccurate or incomplete.
